## **Privacy Notice**

We hold this information for the sole purpose of keeping you in touch with the admissions process and parents can contact the registrar at any point to withdraw from this process, in which case the school will delete any such records.

If you use our site to request admissions information then we will normally store your contact details on a database. This is to allow us to send you other related information in the future and we do not sell, trade or offer this information to others.

### **Data Protection**

We automatically collect some data about our users' browser actions and patterns. This is aggregate data that does not identify any individual, but instead aids in improving our understanding of our users and their preferences. It also helps us develop our website and audit its use.

#### Cookies

This Website uses cookies, a small piece of information stored on your computer in the form of a file, to allow you to access restricted areas and to monitor usage by tracking which URLs are accessed and the sequence in which they are accessed. We use Google Analytics to analyse use of the Website. The information collected will not include any information from which you will be identifiable. You can set up your browser to reject cookies, although some functionality of the website may be impaired. Find out more about how to manage cookies.

### Sending us an email

#### Web Forms

The data will be collated into an email and sent to us over the Simple Mail Transfer Protocol (SMTP). Our SMTP servers are protected by transport layer security (TLS) meaning that the email content is encrypted before being sent across the internet.

You are solely responsible in all aspects for all use of and for protecting the confidentiality of any usernames and passwords that may be given to you or selected by you for use on our website.

#### Web site privacy policy
